

UQ Promotions – Games of Skill

Terms and Conditions

- 1 By entering this promotion, you accept these Terms and Conditions.
- 2 Instructions and information on how to enter this promotion form part of these Terms and Conditions.
- 3 The promoter is The University of Queensland (ABN 63 942 912 684) of St Lucia, Queensland, 4072 ("**Promoter**").

Eligible entrants

- 4 To be eligible to enter this promotion, you must:
 - (a) be a Queensland resident over the age of 18 years;
 - (b) be a current UQ student;
 - (c) must not be a UQ employee or a member of the immediate family of such an employee.

How to enter

- 5 Entry will be open from 10:00 AEST on 18/03/2019 and closes at 23:59 AEST on 24/03/2019 ("**Entry Period**"). Entries received outside of the Entry Period will not be accepted.
- 6 To enter, you must, during the Entry Period:
 - (a) visit <https://ventures.uq.edu.au/qode-competition> and fully complete the online entry form, including: full name, email address, telephone number, student number; and
 - (b) submit a response in 150 words or less to the following question: How will you benefit from attending the event?
- 7 You will receive one entry into the promotion by performing the activities listed above. You may not enter the promotion more than once.
- 8 There are 20 prizes to be won; each prize is a single pass to attend the Exhibition at QODE, held 2nd and 3rd of April 2019, a 2 day forum for innovation and technology.
- 9 All entries become the property of the Promoter.

Judging

- 10 This promotion is a game of skill. Chance plays no part in determining the winners.
- 11 All valid entries will be judged individually on their merits. The entry is judged against how well the entrant responds to the question above.
- 12 Judging will take place at 10:00 AEST on 25/03/2019 at Building 69, The University of Queensland. Entries will be judged by a panel of judges from UQ.
- 13 The Promoter may decline to accept any entry which, in its reasonable opinion, does not comply with these Terms and Conditions.
- 14 The Promoter's decision in relation to any aspect of the promotion is final and the Promoter will not enter into any correspondence regarding the result of the promotion.

Prize and notification of winners

The winner will receive a single pass to attend the Exhibition at QODE, held 2nd and 3rd of April 2019, a 2 day forum for innovation and technology, valid at \$95.

- 15 Prizes are not transferable and cannot be taken as cash.
- 16 The winner will be contacted by email using the email address provided on the form by 26/03/2019. The results will not be published.
- 17 To claim the prize, the winner must reply to the email. The prize must be claimed by 28/03/2019.
- 18 If the Promoter is unable to contact the winner by 28/03/2019 that winner will forfeit the prize and the prize may be awarded to the next best entry (as determined by the judges). The new winner will be contacted by email using the email address on their entry form by 29/03/2019.
- 19 The prize will be delivered to the winner by email within 2 days days after the prize being claimed.
- 20 If any prize becomes unavailable for any reason, the Promoter may substitute a prize of equal or greater value.
- 21 The Promoter accepts no responsibility for any tax implications that may arise for any prize.

Intellectual property

- 22 You confirm and promise that your entry is original and does not infringe the intellectual property rights of any third party. You agree that the Promoter has an unrestricted, irrevocable, transferable, right and licence to use and modify your entry including for promotional purposes without the payment of any further fee or compensation or further reference to you, and that the Promoter can authorise other people to do any of these things.
