

## UQ Promotional Games

### Terms and Conditions (Games of Skill)

- 1 By entering this promotion, you accept these Terms and Conditions.
- 2 Instructions and information on how to enter this promotion form part of these Terms and Conditions.
- 3 The promoter is The University of Queensland (ABN 63 942 912 684) of St Lucia, Queensland, 4072 ("**Promoter**").

### Eligible entrants

- 4 To be eligible to enter this promotion, you must:
  - be over 18 years old and hold a current valid Australian passport:
  - be a team with a minimum of 1 member and a maximum of 4 members. A team member may not be a part of more than one team.

### How to enter

- 5 Entry will be open from 9am] AEST on 19 October 2023 and closes at 12pm AEST on 9 November 2023 ("**Entry Period**"). Entries received outside of the Entry Period will not be accepted.
- 6 To enter, you must, during the Entry Period:
  - visit <https://wkf.ms/3rYcKOQ> and fully complete the online registration before 12pm on 8 November 2023.
  - upload a video pitch no longer than 3 minutes to YouTube and provide link during the Entry Period addressing the Judging Criteria described below.
  - submit a response in 40 words or less to include your startup's name, industry and a brief pitch.
- 7 You will receive one entry into the promotion by performing the activities listed in clause 6. You may not enter the promotion more than once.
- 8 All entries become the property of the Promoter.

### Judging

- 9 This promotion is a game of skill. Chance plays no part in determining the winners.
- 10 All valid entries will be judged individually on their merits. The judging will take place in two phases. First, the judges will undertake a shortlisting process of all eligible entrants based on the video pitch submitted. The Promoter will invite shortlisted applicants to make an oral pitch at the Startup World Cup Pitch event. Second, shortlisted applicants may make their final pitch in person only at the Startup World Cup pitch event, where the judges will vote based on the Judging Criteria. The final pitch is an oral presentation of no more than four minutes at the Startup World Cup pitch event in Brisbane, which may include audio-visual materials. The judges will judge all valid entries individually on their merits, for both the shortlisting and the

final pitch. The entry that is judged to meet the criteria of (a) Value proposition; (b) Solution viability (c) level of innovation, and (d) presentation will be the winner.

11 Judging will take place at 17:00 AEST on 15 November 2023 at The University of Queensland (UQ). Entries will be judged by a panel of judges selected by UQ and Pegasus Tech.Ventures.

12 The Promoter may decline to accept any entry which, in its reasonable opinion, does not comply with these Terms and Conditions.

13 The Promoter's decision in relation to any aspect of the promotion is final and the Promoter will not enter into any correspondence regarding the result of the promotion.

#### **Prize and notification of winners**

14 The winner will win a chance to compete in the Startup World Cup, the largest global startup conference and pitch competition for USD\$1,000,000 plus receiving an economy return ticket from Australia to San Francisco and 5 nights' accommodation in San Francisco. Where a team has more than 1 member, only one nominated member will receive the prize.

15 Prizes are not transferable and cannot be taken as cash.

16 The winner will be contacted by announcement on or by 15 November 2023.

17 To claim the prize, the winner must be present at the Startup World Cup pitch event on 15 November. The prize must be claimed by 15 November 2023.

18 If the Promoter is unable to contact the winner by 15 November 2023, that winner will forfeit the prize and the prize may be awarded to the next best entry (as determined by the judges). The new winner will be contacted by 15 November 2023 on or by 15 November 2023.

19 The prize will be delivered to the winner by issuing of flight ticket and accommodation within 10 days after the prize being claimed.

20 If any prize becomes unavailable for any reason, the Promoter may substitute a prize of equal or greater value.

21 The Promoter accepts no responsibility for any tax implications that may arise for any prize.

#### **Intellectual property**

22 You confirm and promise that your entry is original and does not infringe the intellectual property rights of any third party. You agree that the Promoter has an unrestricted, irrevocable, transferable, right and licence to use and modify your entry including for promotional purposes without the payment of any further fee or compensation or further reference to you, and that the Promoter can authorise other people to do any of these things. If requested by the Promoter, you agree to sign any further documentation required by the Promoter to give effect to this arrangement. To the extent permitted by law, you unconditionally and irrevocably consent to the Promoter modifying your entry as described in this clause, agree that the Promoter is not required to attribute you as author of the entry, and consent to any other act or omission that would otherwise infringe any moral rights in your entry.

#### **Withdrawal from promotion**

23 You may withdraw from the promotion at any time before notification of the winners by notifying the Promoter on ventures@uq.edu.au. If you withdraw from the promotion, the Promoter will remove your entry and will not use your details or entry for media or

promotional purposes. If you withdraw from the promotion, you will no longer be eligible to win a prize.

### **Miscellaneous**

- 24 Entries which, in the opinion of the Promoter, are incomplete, incorrect or incomprehensible, contain defamatory or offensive content or infringe intellectual property rights are not eligible to win and may be removed from the promotion and the relevant entrant will be disqualified.
- 25 The Promoter may, in its absolute discretion, disqualify you if, in the opinion of the Promoter, you breach these Terms and Conditions, engage in dishonest or unethical conduct in relation to the promotion, manipulate, tamper or interfere with the conduct of the promotion, do not comply with the entry process, or conspire with others to gain an unfair advantage. The Promoter may investigate the matter if it suspects you of having engaged in such breach or conduct.
- 26 The Promoter may request information from you relevant to entry or participation in the promotion, such as proof of residency or age. The Promoter may, in its absolute discretion, disqualify you if you provide insufficient information, false information or fail to provide information.
- 27 The Promoter is not responsible for any late, lost or misdirected entries.
- 28 The Promoter is not responsible for any delays, problems or technical malfunction of any telephone network or lines, computer systems, computer equipment or software, technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to your or any other person's computer related to or resulting from entering this promotion. If such problems arise, then the Promoter may modify, cancel, terminate or suspend the promotion.
- 29 To the extent permitted by law, the Promoter is not liable for any loss, damage or injury whatsoever (including, but not limited to, indirect or consequential loss) resulting from this promotion, including the taking of prizes.
