The ilab chapter 1 Pitch Night Prizes

Terms and Conditions

- 1 By entering this promotion, you accept these Terms and Conditions.
- Instructions and information on how to enter this promotion form part of these Terms and Conditions.
- The promoter is The University of Queensland (ABN 63 942 912 684) of St Lucia, Queensland, 4072 ("**Promoter**").

Eligible entrants

- An eligible entrant is a Team consisting of between one and four members. To be eligible to enter this promotion, each Team must:
 - (a) have applied for, been selected for, and successfully completed the 2025 UQ Ventures ilab Chapter 1 Accelerator program ("**Program**"); and
 - (b) send at least one Team member to attend and pitch in person at the ilab Chapter 2 Accelerator Pitch Night being held in Brisbane at The Princess Theatre, 8 Annerley Road, Woolloongabba Qld 4102 from 5.15pm to 9.30pm on Thursday, 10 April 2025 ("Event").

Each Team must contain at least one currently enrolled student, researcher or alumni founder at The University of Queensland. All Team members must be over 18 years of age. An individual Team member may not be a member of more than one Team.

- The Promoter may decline to accept any entry which does not comply with these Terms and Conditions.
- The Promoter may postpone the Event, relocate the Event, or arrange for the Event to take place remotely, if that becomes reasonably necessary in the Promoter's opinion.
- 7 You acknowledge and agree that:
 - (a) the Event is being held for the purpose of showcasing startups that have successfully completed the Program as part of this promotion, and not for the purpose of seeking funding, capital, or investment;
 - (b) you must not use the Event as a forum or opportunity to pitch for, invite or otherwise seek funding, capital, or investment; and
 - (c) presentations made at the Event must not include any offer, invitation, or recommendation to invest.

How to enter

- 8 Eligible Teams enter into the promotion by attending and presenting at the Event a pitch for a proposed business venture of no more than five minutes.
- 9 A Team may not enter the promotion more than once.

Judging

- This promotion is a game of skill. Chance plays no part in determining the winners.
- Judging will take place as follows, upon conclusion of pitches by all Teams:

- (a) ilab Chapter 1 2025 Entrepreneur of the Year prize: The Promoter will select three judges at its discretion (either from industry, or a UQ staff member not involved with the Program). The panel of three judges will deliberate and together choose a winning Team. The Promoter's judges will apply the Judging Criteria and choose the Team which in its view best meets the Judging Criteria, which will win the ilab Chapter 1 2025 Entrepreneur of the year prize;
- (b) ilab Chapter 1 2025 People's Choice prize: Audience members attending the Event will individually vote for the Team, which in each audience member's view, best meets the Judging Criteria, by placing their 'ventures token' in the corresponding Team's token box following the pitches. Each audience member will receive one 'venture token.. At the end of the event, the Promoter will collect all Teams' token boxes and tally their votes. The Team with the most votes will receive The ilab Chapter 1 2025 People's Choice prize.
- (c) ilab Chapter 1 2025 Entrepreneur in Residence Prize: The Promotor will select two individuals from industry to select the winner of the Entrepreneur in Residence Prize. The Entrepreneur in Residence prize will be awarded to the Team that has demonstrated outstanding participation in the Program, significant progress throughout the Program, and strong overall business viability. The selection will be made based on their observations and assessments during the Program. The Team selected will receive The ilab Chapter 1 2025 Entrepreneur in Residence Prize.

The judges and audience will judge all valid entries individually on their merits, including using the following criteria ("Judging Criteria"):

"If you had \$100,000 to invest in one of the ilab chapter 1 2025 startups, which Team's pitch would you consider the best investment for your money?"

The Promoter's decision in relation to any aspect of the promotion is final and the Promoter will not enter into any correspondence regarding the result of the promotion (except for the email referred to in paragraph 14).

Prize and notification of winners

- 13 There are three prizes:
 - (a) The "ilab Chapter 1 2025 Entrepreneur of the Year" prize is the opportunity to receive funding from UniQuest Pty Ltd on the terms of the SAFE Agreement entered between the winning Team and UniQuest Pty Ltd in the amount of \$30,000;
 - (b) the "ilab Chapter 1 2025 People's Choice" prize is a cash prize in the amount of \$7,500, to be awarded to the winning Team members;
 - (c) the "ilab Chapter 1 2025 Entrepreneur in Residence" prize is a cash prize in the amount of \$7,500, to be awarded to the winning Team members.
- The Promoter will announce the winner of the "ilab Chapter 1 2025 Entrepreneur of the Year Prize" at the Event once the judges have finished their deliberations and made their choices. The results of the "ilab Chapter 1 2025 People's Choice" will be announced in an email to be sent to attendees of the Event by Friday 11 April 2025.
- 15 It is possible for a Team to win all three prizes. The Promoter accepts no responsibility for any tax implications, banking or transfer fees that may arise for any prize.

Intellectual property

You confirm and promise that your entry is original (subject to the next sentence) and does not infringe the intellectual property rights of any third party. However, if your entry incorporates intellectual property of any third party (e.g. researchers startups and other mentors), you must

have written permission from that third party to use that intellectual property for the purposes of this promotion.
